Plans and Objectives...


Speedboard have published plans and objectives for the business in line with our policies.

The plans and objectives are reviewed formally at management reviews and additionally as often as the business dictates. An up to date copy can be found on our main notice boards.






The following chart depicts the hierarchy of our management team. A full organisation chart is available on the notice boards and intranet.


The following charts illustrate the basic processes and the interactions with support departments, customers and suppliers.
